	<p>The nationally recognised indicator of good quality educational provision</p> <p>The LOtC Quality Badge provides for the first time a national award combining the essential elements of provision - learning and safety - into ONE easily recognisable and trusted accreditation scheme for ALL types of learning outside the classroom provider throughout the UK. This includes museums, art galleries, adventure centres, nature reserves, science learning centres and farms among many other provider types. The scheme is managed and developed by the <a href="#">Council for Learning Outside the Classroom</a>.</p>
	<p>The Adventure Activities Licensing Authority (AALA) came into existence in April 1996. It is currently sponsored by the Department for Work and Pensions. The Health and Safety Executive is currently designated as the AALA.</p> <p>Adventure activities licensing ensures that activity providers follow good safety management practices. These should allow young people to experience exciting and stimulating activities outdoors without being exposed to avoidable risks of death or disabling injury.</p>
	<p><b>Adventuremark is a non-statutory safety scheme devised by the Adventure Activity Industry Advisory Committee (<a href="#">AAIAC</a>) for providers of adventurous activities that are outside the scope of the <a href="#">Adventure Activity Licensing regulations</a>.</b></p> <p>Adventuremark allows providers to demonstrate to their customers or users that the provider's arrangements for managing the potential risks of adventure activities have been inspected and found to meet the necessary standards of good practice in the adventure activity industry. Adventuremark applies to all adventure activities and to all age groups</p>
	<p>Gold Standard is AHOEC's <b>quality</b> scheme, developed to go beyond the standards set by the LOtC Quality Badge, AAIAC Adventuremark and AALA. Encompassing not just safety but also the best quality of provision, at any provider displaying the <b>Gold Standard</b> logo you can be assured of both safety and quality in their outdoor experience.</p>

#### [ATOL - Protecting holidaymakers since 1973](#)

By law, every UK travel company which sells air holidays and flights is required to hold an ATOL, which stands for Air Travel Organiser's Licence.

If a travel company with an ATOL ceases trading, the ATOL scheme protects customers who had booked holidays with the firm. It ensures they do not get stranded abroad or lose money.

The scheme is designed to reassure consumers that their money is safe, and will provide assistance in the event of a travel company failure.
