



Education Safeguarding Support Services for Schools Financial Year April 2024 to March 2025

Option 1a: The 'Basic' Safeguarding Support Service

The Telford & Wrekin Council, Education & Skills, Achievement & Enrichment, Education Safeguarding Team receive £25,000 of funding to provide a safeguarding support service to schools and academies.

This funding contributes to providing the '**Basic**' **Safeguarding Support Service** detailed below for Telford & Wrekin schools, academies and nursery schools.

All other education settings in Telford & Wrekin, can receive the '**Basic**' **Safeguarding Support Service** identified below at a flat rate of **£770 per year** (£925 for education settings from other LA areas).

The 'Basic' Safeguarding Support Service includes: *(per education setting)*

- **Unlimited** telephone and email support from the Education Safeguarding Team
- **Four-year cyclical safeguarding audit visit** and written note of visit (audit visits will be undertaken more regularly, if required at the discretion of the Service Delivery Manager, Group Manager or Education Safeguarding Coordinator)
- **Annual update** of the Telford & Wrekin Safeguarding Partnership template Child Protection and Safeguarding Policy and access to support workbooks - which include, Record Keeping, Support for Designated Safeguarding Leads and Governors
- **Annually updated** Telford & Wrekin Safeguarding Partnership (Section 175/157) Safeguarding Audit
- **Regular** mailings and provision of up-to-date and relevant information, advice and support via the Education Noticeboard
- **Free attendance** at CSE networks and briefings for schools and colleges
- **One free 'whole-school' bespoke training session annually (delivered in person or via Microsoft Teams).** *This can include Raising Awareness of; Child Protection and Safeguarding in Education training, PREVENT training, Domestic Abuse & Violence training and Child-on-child abuse. A DSL from the school **must** be present for each of the Raising Awareness training sessions.*



Option 1b: The Safeguarding Support 'Plus' Service

The **Safeguarding Support 'Plus' Service** detailed below is available for Telford & Wrekin schools, academies and nursery schools for **£220 per year**. This service is available as an alternative to Option 1a.

All other education settings in Telford & Wrekin, can receive the **Safeguarding Support 'Plus' Service** identified below at a flat rate of **£990 per year** (£1190 for education settings from other Local Authority areas).

The Safeguarding Support 'Plus' Service includes: *(per education setting)*

- **Unlimited** telephone and email support from the Education Safeguarding team
- **Four-year cyclical safeguarding audit visit** and written note of visit
- **Annual update** of the Telford & Wrekin Safeguarding Partnership template Child Protection and Safeguarding Policy and access to support workbooks - which include, Record Keeping, Support for Designated Safeguarding Leads and Governors
- **Annually updated** Telford & Wrekin Safeguarding Partnership (Section 175/157) Safeguarding Audit
- **Regular** mailings and provision of up-to-date and relevant information, advice and support via the Education Noticeboard
- **Free attendance** at CSE networks and briefings for schools and colleges
- Up to **two hours of onsite support per year**, including a written note of visit. Examples of this onsite support may include reviewing the Single Central Record and staff files, monitoring or providing safeguarding supervision, safeguarding learning walk, testing out staff knowledge and skills of safeguarding, general safeguarding advice. *If not used this support will not be rolled over to the following year. Additional visits free of charge may be awarded to manage safeguarding matters at the discretion of the Service Delivery Manager, Group Manager or Education Safeguarding Coordinator*
- **One free 'whole-school' bespoke training session annually** (delivered in person or via Microsoft Teams). *This can include Raising Awareness of; Child Protection and Safeguarding in Education training, PREVENT training, Domestic Abuse & Violence training and Child-on-Child abuse. A DSL from the school **must** be present for each of the Raising Awareness training sessions.*



Option 2a: The school group 'Basic' Safeguarding Support Service

This service is available as an alternative to Option 1a for federations and multi-academy trusts. The support is grouped, based on the number of schools in the federation or academies in the trust. (For example, a multi-academy trust has five academies in Telford & Wrekin. The academy trust would receive five free places per term on the Termly Update for Designated Safeguarding Leads and Safeguarding Governors and five free 'whole-school' bespoke training sessions per year).

For those federations or multi-academy trusts that have schools/academies out of the borough they can access the school group 'Basic' Safeguarding Support Service but there will be a charge of £925 per school/academy located out of borough.

The school group 'Basic' Safeguarding Support Service includes:

- **Unlimited** telephone and email support from the Education Safeguarding team
- **Four-year cyclical safeguarding audit visit** and written note of visit per school or academy (audit visits will be undertaken more regularly, if required at the discretion of the Service Delivery Manager, Group Manager or Education Safeguarding Coordinator)
- **Annual update** of the Telford & Wrekin Safeguarding Partnership template Child Protection and Safeguarding Policy and access to support workbooks - which include, Record Keeping, Support for Designated Safeguarding Leads and Governors
- **Annually updated** Telford & Wrekin Safeguarding Partnership (Section 175/157) Safeguarding Audit
- **Regular** mailings and provision of up-to-date and relevant information, advice and support via the Education Noticeboard
- **Free attendance** at CSE networks and briefings for schools and colleges
- **One free 'whole-school' bespoke training session** annually (delivered in person or via Microsoft Teams), equalling the total number of schools or academies. *This can include Raising Awareness of; Child Protection and Safeguarding in Education training, PREVENT training, Domestic Abuse & Violence training and Child-on-Child Abuse. A DSL from the school **must** be present for each of the Raising Awareness training sessions.*



Option 2b: The school group Safeguarding Support 'Plus' Service

The **Safeguarding Support 'Plus' Service** detailed below is available for Telford & Wrekin federations and multi-academy trusts at a cost of **£220 per year per school or academy in the federation or multi-academy trust**. (For example, a multi-academy trust has five academies in Telford & Wrekin. The charge would be £1100).

This service is available as an alternative to Option 1a, 1b and 2a for federations and multi-academy trusts. The support is grouped, based on the number of schools in the federation or academies in the trust. (For example, a multi-academy trust has five academies in Telford & Wrekin. The academy trust would receive 10 hours of onsite support per year, five free places per term on the Termly Update for Designated Safeguarding Leads and Safeguarding Governors and five free 'whole-school' bespoke training sessions per year).

For those federations or multi-academy trusts that have schools/academies out of the borough they can access the school group Safeguarding Support 'Plus' Service but there will be a charge of £1190 per school/academy located out of borough.

The school group Safeguarding Support 'Plus' Service includes:

- **Unlimited** telephone and email support from the Education Safeguarding team
- **Four-year cyclical safeguarding audit visit** and written note of visit per school or academy (audit visits will be undertaken more regularly, if required at the discretion of the Service Delivery Manager, Group Manager or Education Safeguarding Coordinator)
- **Annual update** of the Telford & Wrekin Safeguarding Partnership template Child Protection and Safeguarding Policy and access to support workbooks - which include, Record Keeping, Support for Designated Safeguarding Leads and Governors
- **Annually updated** Telford & Wrekin Safeguarding Partnership (Section 175/157) Safeguarding Audit
- **Regular** mailings and provision of up-to-date and relevant information, advice and support via the Education Noticeboard
- **Free attendance** at CSE networks and briefings for schools and colleges
- Up to **two hours of onsite support per year – multiplied by the total number of schools or academies**, including a written note of visit. Examples of this onsite support may include reviewing the Single Central Record and staff files, monitoring or providing safeguarding supervision, safeguarding learning walk, testing out staff knowledge and skills of safeguarding, general safeguarding advice. *If not used this support will not be rolled over to the following year. Additional visits free of charge may be awarded to manage safeguarding matters at the discretion of the Service Delivery Manager, Group Manager or Education Safeguarding Coordinator.*
- **One free 'whole-school' bespoke training session annually (delivered in person or via Microsoft Teams), equalling the total number of schools or academies.** *This can include Raising Awareness of; Child Protection and Safeguarding in Education training, PREVENT training, Domestic Abuse & Violence training and Child-on-child abuse. A DSL from the school **must** be present for each of the Raising Awareness training sessions.*



Additional services are available for all education settings purchasing or receiving one of the safeguarding support services, including:

- Safeguarding Supervision Session for DSL's (delivered face-to-face up to two hours) £220* per setting for either group supervision or individual supervision.
- Bespoke consultancy/whole-school training (one session up to three hours) £300* or (one full day up to 6 hours) £600*
- Access to a range of training courses for DSL's, governors and whole-staff teams detailed in the CPD Booklet.

Please note:

- ** A 20% supplement is added to these prices for any schools and organisations outside Telford & Wrekin and any organisations other than schools within Telford & Wrekin, which do not subscribe to this SLA.*
- *Schools booking two or more chargeable places on any of the above centrally organised CPD courses (over and above any free places) will receive a 10% discount on each of the additional places booked – this does not apply to the bespoke consultancy sessions.*
